1. The Himali Rural Municipality has allocated funds to cover eligible payment under the Contract for under table works. Bidding is open to all eligible Nepalese Bidders under National Competitive Bidding Procedures specified in public Procurement Act and Regulations.

  3. Bidders should download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp.np](http://www.bolpatra.gov.np/egp.np). Bidders, should submit their bid electronically only, and should deposit the cost of non-refundable amount of NRs. 3000 for bid in the following details:

5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp.np](http://www.bolpatra.gov.np/egp.np) on or before 12:00 on Dec 13, 2020 (Mangsir 28, 2077). Bids received after this deadline will be rejected.
  6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on Dec 13, 2020 (Mangsir 28, 2077) at the office of Himali Rural Municipality, Bajura. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security. Which bid security shall be valid for 30 days beyond the validity period of the bid.
  7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
  8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
  9. All other issued shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
  10. Any intimidation, collusion and cartelling during bidding process shall be punishable bylaw.
